WHAT TO DO TO PARTICIPATE	<ul> <li>For the educational centers:</li> <li>They can submit their application for the label to the rector of the academy to which you belong.</li> <li>They can submit their application to the rector's office (DAFPIC/DAFCO), which is then sent to the permanent secretariat of the EDUFORM national labeling commission, which studies the admissibility of your application.</li> <li>They then plan their audit with the national auditors designated by the permanent secretariat.</li> <li>They contract the conditions of the audit service.</li> <li>They take part in the national accreditation audit of your structure.</li> <li>They read the audit report drawn up by the auditors.</li> <li>They implement, if necessary, an action plan to deal with nonconformities within the deadlines set out in the Ministry of Labor regulations.</li> </ul>
